

## 2yr NDX/RTY/SPX Auto Callable Contingent Interest Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

**Interest Barrier/Trigger Level:** With respect to each Underlying, an amount that represents 70.00% of its Initial Level.

## Automatic Call

If on any Review Date (other than the final Review Date) the closing level of each Underlying is **greater than or equal to** its Initial Level, the Notes will be automatically called and you will receive a cash payment for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to that Review Date.

## Payment at Maturity

If the notes have not been called and the Final Level of each Underlying is **greater than or equal to** its respective Trigger level, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to the final Review Date.

If the notes have not been called and the Final Level of any Underlying is **less than** its Trigger Level, at maturity you will lose 1% of the principal amount of your notes for every 1% that the Final Level of the Least Performing Underlying is less than its Initial Level, subject to any Contingent Interest Payment payable at maturity. Under these circumstances, your payment at maturity per \$1,000 principal amount note, in addition to any Contingent Interest Payment, will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Underlying Return}).$$

Capitalized terms used but not defined herein shall have the meanings set forth in the preliminary pricing supplement.

## Contingent Interest

\*If the notes have not been called and the closing level of each Underlying on any Review Date is greater than or equal to its Interest Barrier, you will receive on the applicable Interest Payment Date for each \$1,000 principal amount note a Contingent Interest Payment equal to between \$19.375 and \$24.375 (equivalent to an interest rate of between 7.75% and 9.75% per annum, payable at a rate of between 1.9375% and 2.4375% per quarter).

\*\*The hypothetical payments on the notes shown above apply only if you hold the notes for their entire term or until automatically called.
