Summary of Terms

Minimum Denomination: \$1,000

Reference Stock: Common stock of Intel Corporation

Contingent Digital Return: 14.75%

Barrier Amount: At most 68.00% of the Initial Value*

Payment At Maturity:

If the Final Value is greater than or equal to the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Contingent Digital Return})$$

If the Final Value is less than the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Stock Return})$$

If the Final Value is less than the Barrier Amount, you will lose more than 32.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

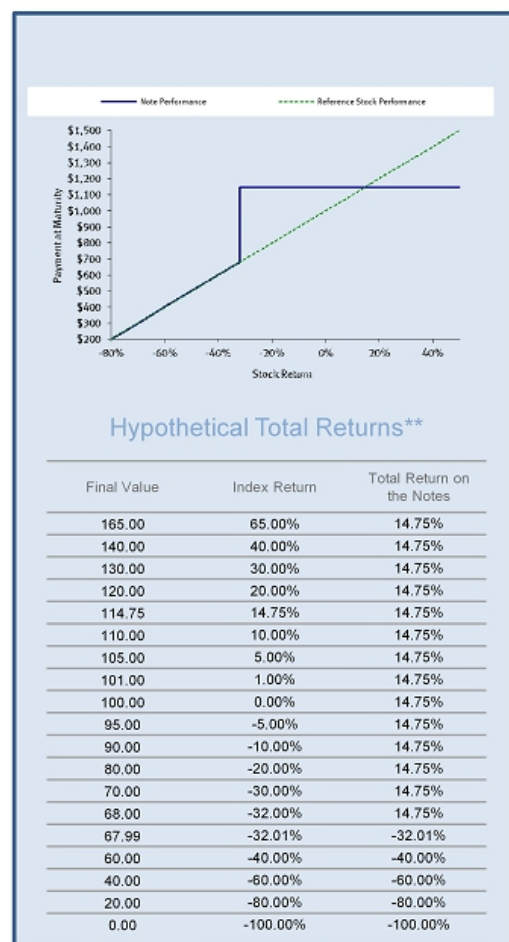
