General

Payment at Maturity:

If the Ending Index Level is greater than the Initial Index Level, you will receive a cash payment that provides you with a return per \$1,000 principal amount note equal to the Index Return multiplied by two, subject to a Maximum Total Return on the notes of 21.60%*. For example, if the Index Return is more than 10.80%, you will receive the Maximum Total Return on the notes of 21.60%*, which entitles you to a maximum payment at maturity of \$1,216 for every \$1,000 principal amount note that you hold. Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table on the preceding page and graph above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 17300 to an Ending Index Level of 18165. Because the Ending Index Level of 18165 is greater than the Initial Index Level of 17300 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 21.60%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

$$1,000 + [1,000 \times (5\% \times 2)] = 1,100$$

Example 2: The level of the Index decreases from the Initial Index Level of 17300 to an Ending Index Level of 15570.

Because the Ending Index Level of 15570 is less than the Initial Index Level of 17300 by not more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index increases from the Initial Index Level of 17300 to an Ending Index Level of 20760.

Because the Ending Index Level of 20760 is greater than the Initial Index Level of 17300 and the Index Return of 20% multiplied by 2 exceeds the hypothetical Maximum Total Return of 21.60%, the investor receives a payment at maturity of \$1,216 per \$1,000 principal amount note, the maximum payment on the notes.

Example 4: The level of the Index decreases from the Initial Index Level of 17300 to an Ending Index Level of 13840.

Because the Ending Index Level of 13840 is less than the Initial Index Level of 17300 by more than the Buffer Amount of 10%, the Index Return is negative and the investor receives a payment at maturity of \$888.89 per \$1,000 principal amount note, calculated as follows:

- APPRECIATION POTENTIAL The notes provide the opportunity to enhance equity returns by multiplying a positive Index Return by two, up to the Maximum Total Return on the notes of 21.60%, or \$1,216 for every \$1,000 principal amount note. - LIMITED PROTECTION AGAINST LOSS Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to 10%. If the Ending Index Level declines by more than 10%, for every 1% decline of the Index beyond 10%, you will lose an amount equal to 1.1111% of the principal amount of your notes.

Selected Risk Considerations
