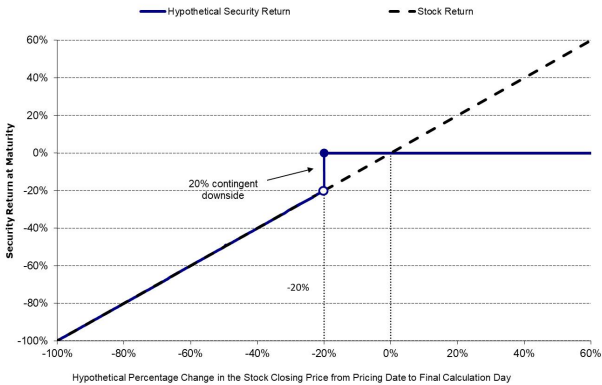
Summary of Terms

Issuer:	JPMorgan Chase Financial Company LLC
Guarantor:	JPMorgan Chase & Co.
Underlying Stock:	The common stock of Apple Inc. (Bloomberg ticker: AAPL) (the “Underlying Stock”)
Pricing Date ¹ :	September 18, 2026
Issue Date ¹ :	September 23, 2026
Stated Maturity Date ^{1, 2} :	September 21, 2028
Principal Amount:	\$1,000 per security (100% of par)
Contingent Coupon Payment:	On each contingent coupon payment date, you will receive a contingent coupon payment at a per annum rate equal to the contingent coupon rate if, and only if , the stock closing price of the Underlying Stock on the related calculation day is greater than or equal to the coupon threshold price. In addition, if the stock closing price of the Underlying Stock on one or more calculation days is less than the coupon threshold price and, on a subsequent calculation day, the stock closing price of the Underlying Stock is greater than or equal to the coupon threshold price, on the contingent coupon payment date related to that subsequent calculation day, you will receive the contingent coupon payment due for that subsequent calculation day <i>plus</i> all previously unpaid contingent coupon payments (without interest on amounts previously unpaid). Each “contingent coupon payment,” if any, will be calculated per security as follows: $(\$1,000 \times \text{contingent coupon rate}) / 4$
Contingent Coupon Payment Dates ^{1, 2} :	Quarterly, on the third business day following each calculation day, <i>provided</i> that the contingent coupon payment date with respect to the final calculation day will be the stated maturity date
Contingent Coupon Rate:	At least 8.25% per annum (to be provided in the pricing supplement)
Automatic Call:	If the stock closing price of the Underlying Stock on any of the calculation days from December 2026 to June 2028, inclusive, is greater than or equal to the starting price, the securities will be automatically called, and on the related call settlement date you will be entitled to receive a cash payment per security in U.S. dollars equal to the principal amount per security <i>plus</i> a final contingent coupon payment and any previously unpaid contingent coupon payments.
Calculation Days ^{1, 2} :	Quarterly, on the 18 th day of each March, June, September and December, commencing December 2026 and ending September 2028. We refer to September 18, 2028 as the “final calculation day.”
Call Settlement Date ^{1, 2} :	Three business days after the applicable calculation day
Maturity Payment Amount (per Security):	If the securities are not automatically called: • If the ending price is greater than or equal to the downside threshold price: \$1,000; or • If the ending price is less than the downside threshold price: $\\$1,000 + (\\$1,000 \times \text{stock return})$
Starting Price:	The stock closing price of the Underlying Stock on the pricing date
Ending Price:	The stock closing price of the Underlying Stock on the final calculation day

If the securities are not automatically called prior to maturity and the ending price is less than the downside threshold price, you will lose more than 20%, and possibly all, of the principal amount of your securities at maturity. Any return on the securities will be limited to the sum of your contingent coupon payments, if any. You will not participate in any appreciation of the Underlying Stock, but you will have full downside exposure to the Underlying Stock on the final calculation day if the ending price is less than the downside threshold price.
