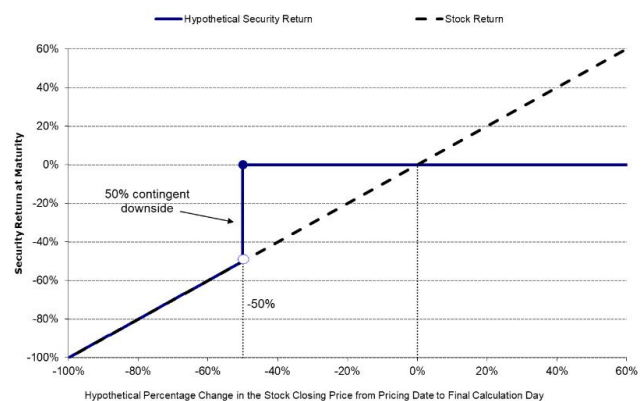
**Summary of Terms**

Underlying Stock:	The Class A common stock of Coinbase Global, Inc. (Bloomberg ticker: COIN) (the “Underlying Stock”)

Principal Amount:	\$1,000 per security (100% of par)
Contingent Coupon Payment:	On each contingent coupon payment date, you will receive a contingent coupon payment at a per annum rate equal to the contingent coupon rate if, <b>and only if</b> , the stock closing price of the Underlying Stock on the related calculation day is greater than or equal to the threshold price. Each “contingent coupon payment,” if any, will be calculated per security as follows:  $(\$1,000 \times \text{contingent coupon rate}) / 4$
Contingent Coupon Payment Dates <sup>1, 2</sup> :	Quarterly, on the third business day following each calculation day, <i>provided</i> that the contingent coupon payment date with respect to the final calculation day will be the stated maturity date
Contingent Coupon Rate:	At least 25.35% per annum (to be provided in the pricing supplement)
Automatic Call:	If the stock closing price of the Underlying Stock on any of the calculation days from May 2026 to November 2028, inclusive, is greater than or equal to the call value, the securities will be automatically called, and on the related call settlement date you will be entitled to receive a cash payment per security in U.S. dollars equal to the principal amount per security <i>plus</i> a final contingent coupon payment.
Call Value:	90% of the starting price
Calculation Days <sup>1, 2</sup> :	Quarterly, on the 11 <sup>th</sup> day of each February, May, August and November, commencing May 2026 and ending February 2029, <i>provided</i> that the February 2029 calculation day will be February 12, 2029. We refer to February 12, 2029 as the “final calculation day.”

Starting Price:	The stock closing price of the Underlying Stock on the pricing date
Ending Price:	The stock closing price of the Underlying Stock on the final calculation day
Stock Return:	$(\text{ending price} - \text{starting price}) / \text{starting price}$
Threshold Price:	50% of the starting price

Denominations:	\$1,000 and any integral multiple of \$1,000
