

## 23m Partial Principal at Risk Notes Linked to SX5E/EFA

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Underlyings:** EURO STOXX 50® Index (the "Index") and iShares® MSCI EAFE ETF (the "Fund")

**Maturity Date:** May 1, 2026  
**Participation Rate:** At least 102.00%\*  
**Additional Amount:** \$1,000 × Lesser Performing Underlying Return × Participation Rate  
**Payment At Maturity:**

If the Final Value of each Underlying is greater than its Initial Value, at maturity, you will receive a cash payment, for each \$1,000 principal amount note, of \$1,000 *plus* the Additional Amount.  
 If the Final Value of either Underlying is equal to or less than its Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$

In no event however, will the payment at maturity be less than \$950.00 per \$1,000 principal amount note.

*If the Final Value of either Underlying is less than its Initial Value, you will lose up to 5.00% of your principal amount at maturity.*

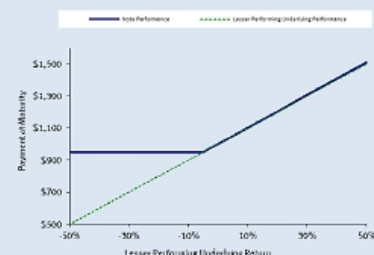

## Selected Risks

## Selected Risks (continued)

- The value of the notes, which may be reflected in customer account statements, may be higher than the then current estimated value of the notes for a limited time period.
- Lack of liquidity: J.P. Morgan Securities LLC (who we refer to as JPMS) intends to offer to purchase the notes in the secondary market but is not required to do so. The price, if any, at which JPMS will be willing to purchase notes from you in the secondary market, if at all, may result in a significant loss of your principal.
