#### General

- This term sheet relates to two (2) separate note offerings. Each issue of offered notes is linked to one, and only one, Reference Stock. You may participate in either of the two (2) note offerings or, at your election, in both of the offerings.   BY US OR AN ISSUER WITH A COMPARABLE CREDIT RATING The notes will pay interest at an Interest Rate depending upon the
  applicable Reference Stock, as indicated on the cover of this term sheet. We believe that the applicable Interest Rate is higher than the
  yield received on debt securities of comparable maturity issued by us or an issuer with a comparable credit rating. Because the notes are
  our senior unsecured obligations, any interest payment or any payment at maturity is subject to our ability to pay our obligations as they
  become due.
- MONTHLY INTEREST PAYMENTS The notes offer monthly interest payments at the applicable Interest Rate set forth on the cover of this term sheet. ## Selected Risk Considerations



Because the Final Share Price of \$174.00 is greater than the Initial Share Price of \$173.00, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

**Example 2: The lowest closing price of the Reference Stock during the Monitoring Period was \$86.50 and the Final Share Price is \$172.00.** Because the Final Share Price of \$172.00 is less than the Initial Share Price of \$173.00 and the closing price of the Reference Stock declined by more than the Protection Amount on at least one day during the Monitoring Period, you will receive the Physical Delivery Amount, or at



Because the Final Share Price of \$17.50 is less than the Initial Share Price of \$35.00 and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$17.50, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$500.

Example 4: The Final Share Price of \$26.25 is less than the Initial Share Price of \$35.00 but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note, even though the Final Share Price of \$26.25 is less than the Initial Share Price of \$35.00.
