The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 18000 to an Index Closing Level of 19800 on the first Review Date. Because the Index Closing Level on the first Review Date of 19800 is greater than the Call Level of 18000, the notes are automatically called, and the investor receives a single payment of \$1,132 per \$1,000 principal amount note.

Example 2: The level of the Index decreases from the Initial Index Level of 18000 to an Index Closing Level of 17982 on the first Review Date, 17100 on the second Review Date and 16200 on the final Review Date. Because (a) the Index Closing Level on each of the Review Dates (17982, 17100 and 16200) is less than the Call Level of 18000, and (b) the Ending Index Level has not declined by more than 10% from the Initial Index Level, the notes are not called and the payment at maturity is the principal amount of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index decreases from the Initial Index Level of 18000 to an Index Closing Level of 17982 on the first Review Date, 16200 on the second Review Date and 14400 on the final Review Date. Because (a) the Index Closing Level on each of the Review Dates (17982, 16200 and 14400) is less than the Call Level of 18000, and (b) the Ending Index Level is more than 10% below the Initial Index Level, the notes are not called and the investor receives a payment at maturity that is less than the principal amount for each \$1,000 principal amount note, calculated as follows:


