

## 2yr TSM Contingent Income Auto-Callable Securities

**This document provides a summary of the terms of the securities. Investors must carefully review the accompanying preliminary pricing supplement referenced below, product supplement, prospectus supplement and prospectus and the "Risk Considerations" on the following page, prior to making an investment decision.**

### SUMMARY TERMS

<b>Issuer:</b>	JPMorgan Chase Financial Company LLC ("JPMorgan Financial")
<b>Guarantor:</b>	JPMorgan Chase & Co.
<b>Underlying stock:</b>	American depositary shares of Taiwan Semiconductor Manufacturing Company Limited ("Taiwan Semiconductor ADSs") (Bloomberg ticker: TSM UN Equity). Each Taiwan Semiconductor ADS represents five common shares, par value NT\$10.00 per share, of Taiwan Semiconductor Manufacturing Company Limited. The common shares of Taiwan Semiconductor Manufacturing Company Limited are referred to as "Taiwan Semiconductor underlying securities."
<b>Early redemption:</b>	<p>If, on any determination date (other than the final determination date), the closing price of the underlying stock is <b>greater than or equal to</b> the initial stock price, the securities will be automatically redeemed for an early redemption payment on the first contingent payment date immediately following the related determination date. No further payments will be made on the securities once they have been redeemed.</p> <p><b>The securities will not be redeemed early on any contingent payment date if the closing price of the underlying stock is below the initial stock price on the related determination date.</b></p>
<b>Early redemption payment:</b>	The early redemption payment will be an amount equal to (i) the stated principal amount <i>plus</i> (ii) the contingent quarterly payment with respect to the related determination date.
<b>Contingent quarterly payment:</b>	<ul style="list-style-type: none"> <li>If, on any determination date, the closing price of the underlying stock is greater than or equal to the downside threshold level, we will pay a contingent quarterly payment of at least \$29.00 (at least 2.90% of the stated principal amount) per security on the related contingent payment date. The actual contingent quarterly payment will be provided in the pricing supplement.</li> <li>If, on any determination date, the closing price of the underlying stock is less than the downside threshold level, no contingent quarterly payment will be made with respect to that determination date. <b>It is possible that the closing price of the underlying stock will be below the downside threshold level on most or all of the determination dates so that you will receive few or no contingent quarterly payments.</b></li> </ul>

The stock adjustment factor is subject to adjustment in the event of certain corporate events affecting the underlying stock.
