

## 5yr IWM/DIA/QQQ Uncapped Dual Directional Digital Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

 If the Final Value of any Fund is less than its Initial Value but the Final Value of each Fund is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Absolute Fund Return of the Least Performing Fund})$$
  
 If the Final Value of any Fund is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Least Performing Fund Return})$$

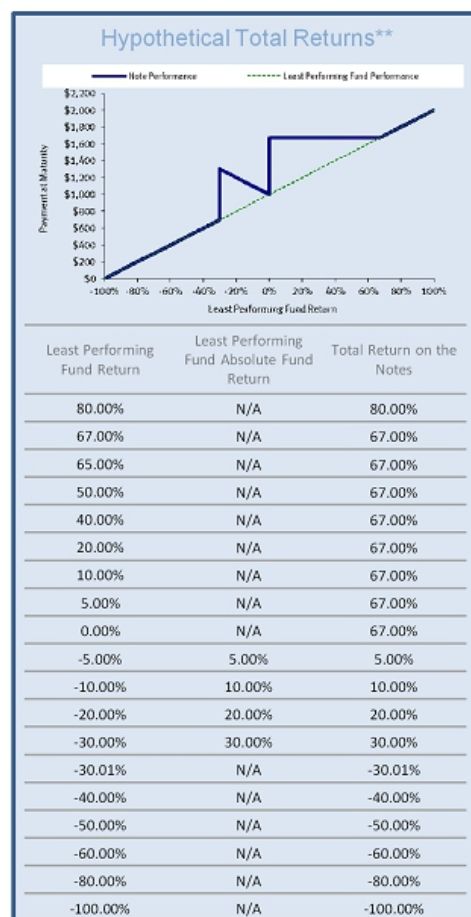

## Selected Risks (continued)
