General

- Minimum denominations of \$50,000 and integral multiples of \$1,000 in excess thereof.

The following table assumes that the Lesser Performing Index used to calculate the Ending Index Level will be the S&P 500[®] Index. We make no representation or warranty as to which of the Indices will be the Lesser Performing Index for the purposes of calculating your return on the notes at maturity. The following table and graph also assume a Participation Rate of 300%, a hypothetical Initial Index Level of 1500 for the Lesser Performing Index and a Maximum Return of 10.65%, or \$106.50 per \$1,000 principal amount note. 

Hypothetical Examples of Amounts Payable At Maturity

The following examples illustrate how the total returns set forth in the table on the previous page are calculated.

Example 1: The level of the Lesser Performing Index increases from its Initial Index Level of 1500 to an Ending Index Level of 1545. Because the Lesser Performing Index's Ending Index Level of 1545 is greater than its Initial Index Level and the Lesser Index Return of 3% multiplied by 300% does not exceed the hypothetical Maximum Return of 10.65%, the Additional Amount is equal to \$90 and the investor receives a payment at maturity of \$1,090 per \$1,000 principal amount note, calculated as follows:

\$1,000 + (\$1,000 × [(1545-1500)/1500] × 300%) = \$1,090

Example 2: The level of the Lesser Performing Index decreases from its Initial Index Level of 1500 to an Ending Index Level of 1350. Because the Lesser Performing Index's Ending Index Level of 1350 is lower than its Initial Index Level, the final payment per \$1,000 principal amount note at maturity is the principal amount of \$1,000.

Example 3: The level of the Lesser Performing Index increases from its Initial Index Level of 1500 to an Ending Index Level of 1650. Because the Lesser Performing Index's Ending Index Level of 1650 is greater than its Initial Index Level and the Lesser Index Return of 10% multiplied by 300% is greater than the hypothetical Maximum Return of 10.65%, the Additional Amount is equal to the hypothetical Maximum Return of \$1,106.50 per \$1,000 principal amount note.

Selected Purchase Considerations

- PRESERVATION OF CAPITAL AT MATURITY You will receive at least 100% of the principal amount of your notes if you hold your notes to maturity regardless of the performance of the Indices. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- APPRECIATION POTENTIAL At maturity, in addition to your principal, for each \$1,000 principal amount note you will receive a payment equal to \$1,000 x the Lesser Index Return x 300% (the Participation Rate), but this additional payment will not be less than zero or greater than \$106.50* per \$1,000 principal amount note, which reflects the Maximum Return of 10.65%^{*} on the notes.
 *The actual Maximum Return will be determined on the pricing date and will not be less than 10.65%.

therefore, are among the most actively traded on that exchange. The S&P 500[®] Index consists of 500 component stocks selected to provide a performance benchmark for the U.S. equity markets. • TAXED AS SHORT-TERM DEBT INSTRUMENTS — You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 16-III. The pricing of the notes is subject to delivery of an opinion of our special tax counsel, Davis Polk & Wardwell, that the notes will be treated as "short-term" debt instruments. The opinion will be subject to the limitations described in the section entitled "Certain U.S. Federal Income Tax Consequences" in product supplement 16-III and will be based on certain factual representations to be received from us on or prior to the pricing date. No statutory, judicial or administrative authority directly addresses the treatment of the notes or instruments similar to the notes for U.S. federal income tax purposes, and no ruling is being requested from the Internal Revenue Service with respect to the notes. Selected Risk Considerations

An investment in the notes involves significant risks. Investing in the notes is not equivalent to investing directly in the Indices or any of the component stocks of the Indices. These risks are explained in more detail in the "Risk Factors" section of the accompanying product supplement no. 16-III dated February 9, 2007.

- MARKET RISK The return on the notes at maturity is linked to the performance of the Lesser Performing Index, and will depend on whether, and the extent to which, the Lesser Index Return is positive. The two Indices' respective performances may not be correlated and, as a result, your investment in the notes may only produce a positive return if there is a broad-based rise in the performance of equities across diverse markets over the term of the notes. You will receive no more than the full principal amount of your notes if the Lesser Index Return is zero or negative.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM RETURN If the Ending Index Level of the Lesser Performing
 Index is greater than its Initial Index Level for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional
 amount that will not exceed a predetermined percentage of the principal amount, regardless of the appreciation in the Lesser Performing

- CERTAIN BUILT-IN COSTS ARE LIKELY TO ADVERSELY AFFECT THE VALUE OF THE NOTES PRIOR TO MATURITY While the payment at maturity described in this term sheet no. 10-A is based on the full principal amount of your notes, the original issue price of the notes includes the agent's commission and the cost of hedging our obligations under the notes through one or more of our affiliates. As a result, the price, if any, at which J.P. - NO DIRECT EXPOSURE TO FLUCTUATIONS IN FOREIGN EXCHANGE RATES The value of your notes will not be adjusted for
 exchange rate fluctuations between the U.S. dollar and the currencies in which the stocks composing the Nikkei 225 Index are
 denominated, although any currency fluctuations could affect the performance of the Nikkei 225 Index. Therefore, if the applicable
 currencies appreciate or depreciate relative to the U.S. dollar over the term of the notes, you will not receive any additional payment or incur
 any reduction in your payment at maturity.
- LACK OF LIQUIDITY The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMSI is willing to buy the notes.
- **POTENTIAL CONFLICTS** We and our affiliates play a variety of roles in connection with the issuance of the notes, including acting as calculation agent and hedging our obligations under the notes. In performing these duties, the economic interests of the calculation agent and other affiliates of ours are potentially adverse to your interests as an investor in the notes. In addition, we are currently one of the companies that make up the S&P 500[®] Index. We will not have any obligation to consider your interests as a holder of the notes in taking any corporate action that might affect the value of the S&P 500[®] Index and the notes.
- MANY ECONOMIC AND MARKET FACTORS WILL IMPACT THE VALUE OF THE NOTES In addition to the level of the Indices on any day, the value of the notes will be affected by a number of economic and market factors that may either offset or magnify each other, including:
 - the expected volatility in each Index;
 - the time to maturity of the notes;
 - the dividend rate on the common stocks underlying each Index;
 - the expected positive or negative correlation between the Nikkei 225 Index and the S&P 500[®] Index, or the expected absence of any such correlation;
 - interest and yield rates in the market generally;
 - a variety of economic, financial, political, regulatory or judicial events;

- the exchange rate and volatility of the exchange rate between the dollar and the yen; and
- our creditworthiness, including actual or anticipated downgrades in our credit ratings.
- THE OFFERING OF THE NOTES MAY BE TERMINATED BEFORE PRICING This term sheet no. 10-A has not been reviewed by our special tax counsel, Davis Polk & Wardwell, and the pricing of the offering of the notes is subject to delivery by them of an opinion regarding the tax treatment of the notes as described under "Selected Purchase Considerations Taxed as Short-Term Debt Instruments" above. If our special tax counsel does not deliver this opinion prior to pricing, the offering of the notes will be terminated.


