Automatic Call

If the closing level of each Index on any Review Date is greater than or equal to the applicable Call Value, the notes will be automatically called for a cash payment, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Call Premium Amount applicable to that Review Date, payable on the applicable Call Settlement Date. No further payments will be made on the notes.

Payment at Maturity

If the notes have not been automatically called (and therefore the Final Value of any Index is less than its Barrier Amount), your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Index Return})$$

If the notes have not been automatically called (and therefore the Final Value of any Index is less than its Barrier Amount), you will lose more than 25.00% of your principal amount at maturity and could lose all of your principal amount at maturity.
