

## 5yr SPX/RTY Digital Barrier Notes

## Summary of Terms

**Observation Date:** October 22, 2026  
**Maturity Date:** October 27, 2026  
**Contingent Digital Return:** At least 36.00%\*  
**Barrier Amount:** With respect to each Index, 75.00% of its Initial Value  
**Payment At Maturity:** If the Final Value of each Index is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + \$1,000 \times \text{Contingent Digital Return}$$
  
 If the Final Value of either Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + \$1,000 \times (\text{Lesser Performing Index Return})$$

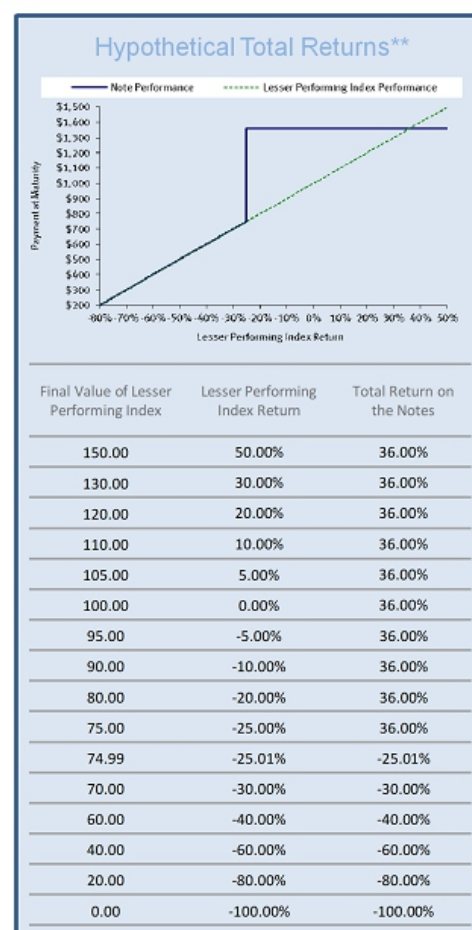
