

## 13m RTY/SPX Digital Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

**Estimated Value:** The estimated value of the notes, when the terms of the notes are set, will not be less than \$900.00 per \$1,000 principal amount note. ## Payment at Maturity

If the Final Value of each Underlying is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Contingent Digital Return})$$

If the Final Value of either Underlying is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$

*If the Final Value of either Underlying is less than its Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

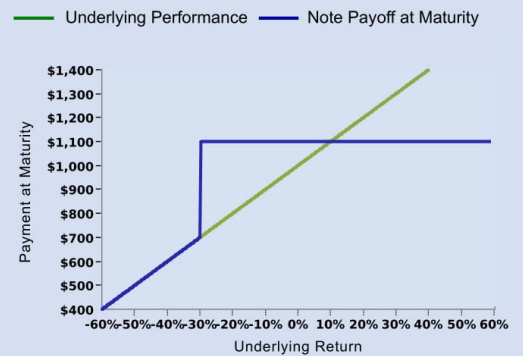

## Selected Risks
