

## 5y SPXFP Uncapped Dual Directional Digital Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Issuer:** JPMorgan Chase Financial Company LLC  
**Guarantor:** JPMorgan Chase & Co.  
**Minimum Denomination:** \$1,000  
**Index:** S&P 500® Futures Excess Return Index  
**Pricing Date:** July 10, 2024  
**Observation Date:** July 10, 2029  
**Maturity Date:** July 13, 2029  
**Contingent Digital Return:** At least 51.20%\*  
**Barrier Amount:** 60.00% of the Initial Value  
**Payment At Maturity:** If the Final Value is greater than or equal to the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{greater of (a) Contingent Digital Return and (b) Index Return})$$

If the Final Value is less than the Initial Value but the Final Value is greater than or equal to the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Absolute Index Return})$$

*This payout formula results in an effective cap of 40.00% on your return at maturity if the Index Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,400.00 per \$1,000 principal amount note.*

If the Final Value is less than the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return})$$

*If the Final Value is less than the Barrier Amount, you will lose more than 40.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

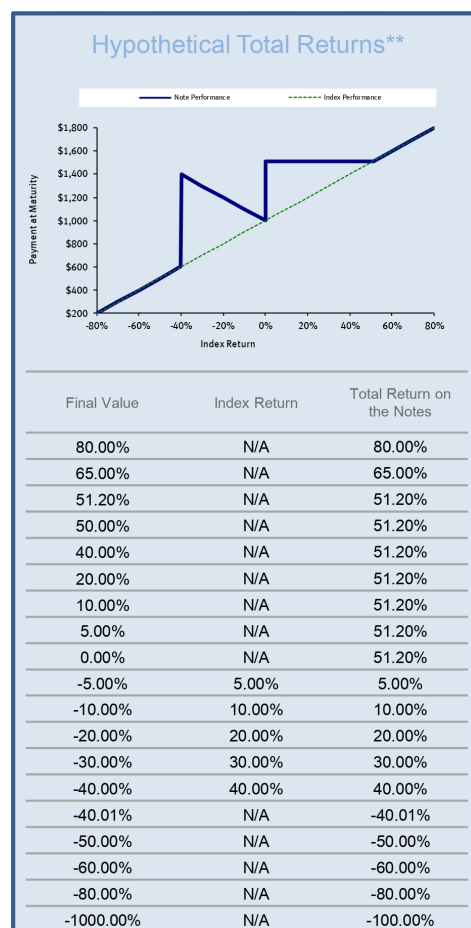
