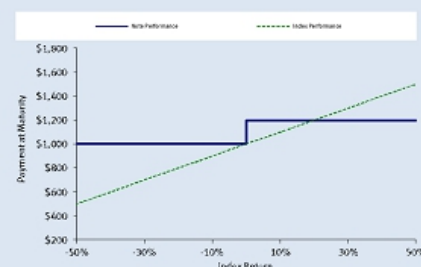

Selected Risks
