
#### What Is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?



Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

**Example 1: The level of the Index increases from the EURO STOXX Starting Level of 4400 to a EURO STOXX Closing Level of 4510.** Because the EURO STOXX Closing Level of 4510 is greater than the EURO STOXX Starting Level of 4400 and the EURO STOXX Return of 2.5% multiplied by two does not exceed the hypothetical Maximum Total Return of 8.50%, the investor receives a payment at maturity of \$1,050 per \$1,000 principal amount note, calculated as follows:

**Example 2: The level of the Index increases from the EURO STOXX Starting Level of 4400 to a EURO STOXX Closing Level of 5060.** Because the EURO STOXX Closing Level of 5060 is greater than the EURO STOXX Starting Level of 4400 and the EURO STOXX Return of 15% multiplied by two exceeds the hypothetical Maximum Total Return of 8.50%, the investor receives a payment at maturity of \$1,085 per \$1,000 principal amount note, the maximum payment on the notes.

**Example 3: The level of the Index decreases from the EURO STOXX Starting Level of 4400 to a EURO STOXX Closing Level of 3520.** Because the EURO STOXX Closing Level of 3520 is less than the EURO STOXX Starting Level of 4400, the EURO STOXX Return is negative and the investor receives a payment at maturity of \$800 per \$1,000 principal amount note, calculated as follows:


- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal. The return on the
  notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the EURO STOXX Return is
  positive or negative. Your investment will be fully exposed to any decline in the EURO STOXX Closing Level as compared to the EURO
  STOXX Starting Level.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the EURO STOXX Closing Level is
