General


What Is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?


The following table and graph illustrate the hypothetical total return at maturity on the notes. The "total return" as used in this term sheet is the number, expressed as a percentage, that results from comparing the payment at maturity per \$1,000 principal amount note to \$1,000. The hypothetical total returns set forth below assume a EURO STOXX Starting Level of 4400 and a Maximum Total Return on the notes of 8.50%. The hypothetical total returns set forth below are for illustrative purposes only and may not be the actual total returns applicable to a purchaser of the notes. Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

Example 1: The level of the Index increases from the EURO STOXX Starting Level of 4400 to a EURO STOXX Closing Level of 4510. Because the EURO STOXX Closing Level of 4510 is greater than the EURO STOXX Starting Level of 4400 and the EURO STOXX Return of 2.5% multiplied by two does not exceed the hypothetical Maximum Total Return of 8.50%, the investor receives a payment at maturity of \$1,050 per \$1,000 principal amount note, calculated as follows:

Example 2: The level of the Index increases from the EURO STOXX Starting Level of 4400 to a EURO STOXX Closing Level of 5060. Because the EURO STOXX Closing Level of 5060 is greater than the EURO STOXX Starting Level of 4400 and the EURO STOXX Return of 15% multiplied by two exceeds the hypothetical Maximum Total Return of 8.50%, the investor receives a payment at maturity of \$1,085 per \$1,000 principal amount note, the maximum payment on the notes.

Example 3: The level of the Index decreases from the EURO STOXX Starting Level of 4400 to a EURO STOXX Closing Level of 3520. Because the EURO STOXX Closing Level of 3520 is less than the EURO STOXX Starting Level of 4400, the EURO STOXX Return is negative and the investor receives a payment at maturity of \$800 per \$1,000 principal amount note, calculated as follows:

Selected Purchase Considerations

Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.


- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal. The return on the
 notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the EURO STOXX Return is
 positive or negative. Your investment will be fully exposed to any decline in the EURO STOXX Closing Level as compared to the EURO
 STOXX Starting Level.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the EURO STOXX Closing Level is
 greater than the EURO STOXX Starting Level, for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional
 amount that will not exceed a predetermined percentage of the principal amount, regardless of the appreciation in the Index, which may be
 significant. We refer to this percentage as the Maximum Total Return, which will be set on the pricing date and will not be less than 8.50%.
- CERTAIN BUILT-IN COSTS ARE LIKELY TO ADVERSELY AFFECT THE VALUE OF THE NOTES PRIOR TO MATURITY While the payment at maturity described in this term sheet is based on the full principal amount of your notes, the original issue price of the notes includes the agent's commission and the cost of hedging our obligations under the notes through one or more of our affiliates. As a result, the price, if any, at which J.P. Morgan Securities Inc., whom we refer to as JPMSI, will be willing to purchase notes from you in secondary market transactions, if at all, will likely be lower than the original issue price, and any sale prior to the maturity date could result in a substantial loss to you. The notes are not designed to be short-term trading instruments. Accordingly, you should be able and willing to hold your notes to maturity.
- NO DIRECT EXPOSURE TO FLUCTUATIONS IN FOREIGN EXCHANGE RATES The value of your notes will not be adjusted for
 exchange rate fluctuations between the U.S. dollar and the currencies in which the stocks composing the Index are denominated, although
 any currency fluctuations could affect the performance of the Index. Therefore, if the applicable currencies appreciate or depreciate relative
 to the U.S. dollar over the term of the notes, you will not receive any additional payment or incur any reduction in your payment at maturity.
- NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS As a holder of the notes, you will not receive interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of securities composing the Index would have.
- LACK OF LIQUIDITY The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily.
