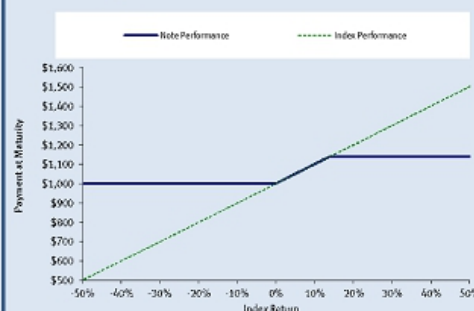

Selected Risks
