What Is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?



Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 830 to an Ending Index Level of 871.50. Because the Ending Index Level of 871.50 is greater than the Initial Index Level of 830 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 19.80%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

Example 2: The level of the Index increases from the Initial Index Level of 830 to an Ending Index Level of 954.50. Because the Ending Index Level of 954.50 is greater than the Initial Index Level of 830 and the Index Return of 15% multiplied by 2 exceeds the hypothetical Maximum Total Return of 19.80%, the investor receives a payment at maturity of \$1,198 per \$1,000 principal amount note, the maximum payment on the notes.

Example 3: The level of the Index decreases from the Initial Index Level of 830 to an Ending Index Level of 664.

Because the Ending Index Level of 664 is less than the Initial Index Level of 830, the Index Return is negative and the investor receives a payment at maturity of \$800 per \$1,000 principal amount note, calculated as follows:

Selected Purchase Considerations

Selected Risk Considerations

- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal. The return on the
 notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive
 or negative. Your investment will be fully exposed to any decline in the Ending Index Level as compared to the Initial Index Level.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the Ending Index Level is greater than
 the Initial Index Level, for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional amount that will not
