General

- The notes are designed for investors who seek an unleveraged return equal to the appreciation of the S&P 500[®] Index, **without upside return enhancement**, up to a maximum total return on the notes that will not be less than 36.65%* at maturity. Investors should be willing to forgo interest and dividend payments and, if the Index declines by more than 12.5%, be willing to lose up to 90% of their principal.
- Senior unsecured obligations of JPMorgan Chase & Co. maturing September 10, 2010[†].
- Minimum denominations of \$1,000 and integral multiples thereof.
- The notes are expected to price on or about March 6, 2009 and are expected to settle on or about March 11, 2009.

Key Terms

Index: The S&P 500® Index (the "Index")

Upside Leverage Factor: One (1). There is no upside return enhancement.

Payment at Maturity:

If the Ending Index Level is greater than the Initial Index Level, you will receive a cash payment that provides you with a return per \$1,000 principal amount note equal to the Index Return, subject to a Maximum Total Return on the notes that will not be less than 36.65%* at maturity. For example, assuming a Maximum Total Return of 36.65%*, if the Index Return is equal to or greater than 36.65%, you will receive the Maximum Total Return on the notes of 36.65%*, which entitles you to a maximum payment at maturity of \$1,366.50* for every \$1,000 principal amount note that you hold. Accordingly, if the Index Return is positive, your payment per \$1,000 principal amount note will be calculated as follows, subject to the Maximum Total Return:

Selected Purchase Considerations

- UNLEVERAGED APPRECIATION POTENTIAL The notes provide the opportunity to earn an unleveraged return equal to the appreciation of the Index Return, without upside return enhancement, up to the Maximum Total Return on the notes. The actual Maximum Total Return on the notes will be set on the pricing date and will not be less than 36.65%. Accordingly, the maximum payment at maturity will not be less than \$1,366.50 for every \$1,000 principal amount note. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- LIMITED PROTECTION AGAINST LOSS Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to 12.5%. If the Ending Index Level declines by more than 12.5%, for every 1% decline of the Index beyond 12.5%, you will lose an amount equal to 1% of the principal amount of your notes. Accordingly, at maturity you will receive a payment equal to at least \$125 for each \$1,000 principal amount note.

- DIVERSIFICATION OF THE S&P 500® INDEX The return on the notes is linked to the S&P 500® Index. The S&P 500® Index consists of 500 component stocks selected to provide a performance benchmark for the U.S. equity markets. For additional information about the Index, see the information set forth under "The S&P 500® Index" in the accompanying product supplement no. 39-A-II.
- **CAPITAL GAINS TAX TREATMENT** You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 39-A-II. As described therein, we and you will agree to characterize and treat the notes for U.S. federal income tax purposes as "open transactions". Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Sidley Austin LLP, it is reasonable to treat your purchase and ownership of the notes as "open transactions" for U.S. federal income tax purposes. Assuming this characterization is respected, your gain or loss on the notes should be treated as long-term capital gain or loss if you hold the notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service (the "IRS") or a court may not respect this characterization or treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. For example, the notes could be treated either as subject (in whole or in part) to the "constructive ownership transaction" rules of Section 1260 of the Internal Revenue Code, as discussed in the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 39-A-II, or as "contingent payment debt instruments." Moreover, on December 7, 2007, the Treasury Department and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments, such as the notes. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; the relevance of factors such as the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by Non-U.S. Holders should be subject to withholding tax; and whether these instruments are or should be subject to the "constructive ownership" regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income that is subject to an interest charge. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the notes, possibly with retroactive effect. Selected Risk Considerations

An investment in the notes involves significant risks. Investing in the notes is not equivalent to investing directly in any of the equity securities underlying the Index. - YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal in excess of \$125 per \$1,000 principal amount note. The return on the notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive or negative. Your investment will be exposed to any decline in the Ending Index Level, as compared to the Initial Index Level, beyond the 12.5% buffer. Accordingly, you could lose up to \$875 for each \$1,000 principal amount note that you invest in.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the Ending Index Level is greater than the Initial Index Level, for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional amount that will not exceed a predetermined percentage of the principal amount, regardless of the appreciation in the Index, which may be significant. - NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS As a holder of the notes, you will not receive interest payments, and
 you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of equity securities
 composing the Index would have.
- LACK OF LIQUIDITY The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMSI is willing to buy the notes.

Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 700 to an Ending Index Level of 770. Because the Ending Index Level of 770 is greater than the Initial Index Level of 700 and the Index Return of 10% does not exceed the hypothetical Maximum Total Return of 36.65%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times 10\%) = 1,100$$

Example 2: The level of the Index decreases from the Initial Index Level of 700 to an Ending Index Level of 665. Because the Ending Index Level of 665 is less than the Initial Index Level of 700 by not more than the Buffer Amount of 12.5%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index decreases from the Initial Index Level of 700 to an Ending Index Level of 560. Because the Ending Index Level of 560 is less than the Initial Index Level of 700 by more than the Buffer Amount of 12.5%, the investor receives a payment at maturity of \$925 per \$1,000 principal amount note, calculated as follows:

$$1.000 + [1.000 \times (-20\% + 12.5\%)] = 925$$

Example 4: The level of the Index increases from the Initial Index Level of 700 to an Ending Index Level of 1050. Because the Ending Index Level of 1050 is greater than the Initial Index Level of 700, and the Index Return of 50% exceeds the hypothetical Maximum Total Return of 36.65%, the investor receives a payment at maturity of \$1,366.50 per \$1,000 principal amount note, the maximum payment on the notes.

Example 5: The level of the Index decreases from the Initial Index Level of 700 to an Ending Index Level of 0. Because the Ending Index Level of 0 is less than the Initial Index Level of 700 by more than the Buffer Amount of 12.5%, the investor receives a payment at maturity of \$125 per \$1,000 principal amount note, which reflects the principal protection provided by the 12.5% Buffer Amount, calculated as follows:
