Payment At Maturity:

In no event however, will the payment at maturity be less than \$950.00 per \$1,000 principal amount note.

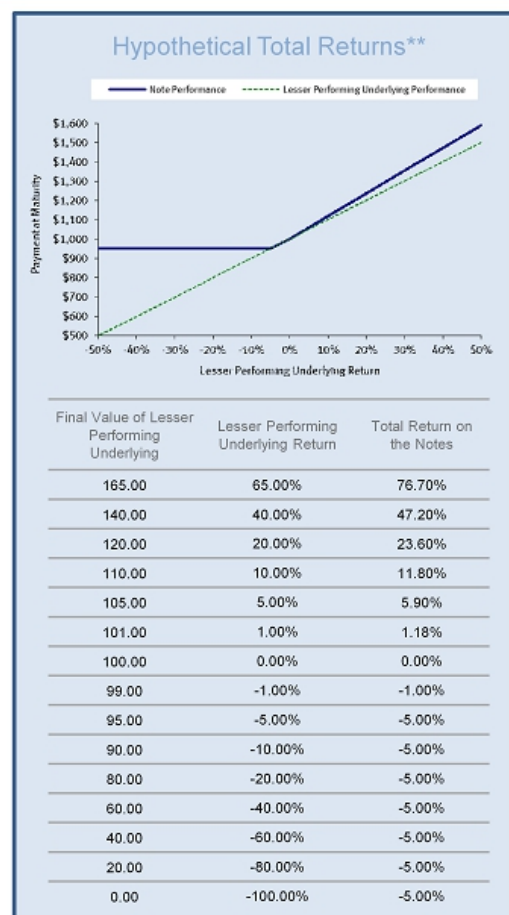
