

1.5yr SX5E/EEM Contingent Buffered Digital Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Underlyings: EURO STOXX 50® Index (the "Index") and iShares® MSCI Emerging Markets ETF (the "Fund") (each of the Index and the Fund, an "Underlying" and collectively, the "Underlyings")
Pricing Date: July 19, 2019
Observation Date: January 19, 2021
Maturity Date: January 22, 2021
Contingent Digital Return: At least 11.70%*
Contingent Buffer Amount: 25.00%
Payment At Maturity: If the Final Value of each Underlying is greater than or equal to its Initial Value or is less than its Initial Value by up to the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Contingent Digital Return})$$

If the Final Value of either Underlying is less than its Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$

If the Final Value of either Underlying is less than its Initial Value by more than the Contingent Buffer Amount, you will lose more than 25.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

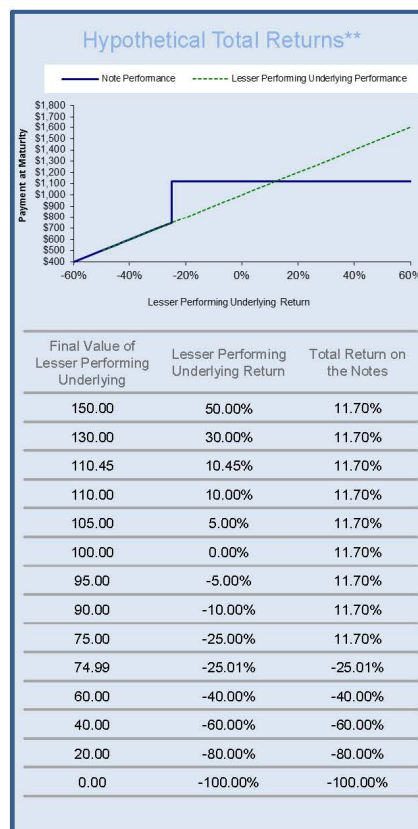
