The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

Summary of Terms

Indices: S&P 500® Index and Russell 2000® Index
Pricing Date: February 17, 2023
Observation Date: April 9, 2024
Maturity Date: April 12, 2024
Contingent Digital Return: 8.50%
Barrier Amount: With respect to each Index, between 60.00% and 62.00% of its Initial Value*
Payment At Maturity: If the Final Value of each Index is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Contingent Digital Return})$$

If the Final Value of either Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$$

If the Final Value of either Index is less than its Barrier Amount, you will lose more than between 40.00% (if the Barrier Amount of each Index is set equal to 60.00% of its Initial Value) and 38.00% (if the Barrier Amount of each Index is set equal to 62.00% of its Initial Value) of your principal amount at maturity and could lose all of your principal amount at maturity.


