

## 18m Equally Weighted Basket (SPW/RIY) Capped Buffered Return Enhanced Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Issuer:** JPMorgan Chase Financial Company LLC  
**Guarantor:** JPMorgan Chase & Co.  
**Minimum Denomination:** \$1,000  
**Basket:** The notes are linked to an equally weighted basket consisting of the following:  
 • 50.00% of the S&P 500® Equal Weight Index; and  
 • 50.00% of the Russell 1000® Index (each an "Index" and collectively, the "Indices").  
**Pricing Date:** March 27, 2024  
**Observation Date:** September 29, 2025  
**Maturity Date:** October 2, 2025  
**Upside Leverage Factor:** 2.00  
**Maximum Return:** At least 15.25%\*  
**Buffer Amount:** 15.00%  
**Downside Leverage Factor:** 1.17647  
**Payment At Maturity:** If the Final Basket Value is greater than the Initial Basket Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  
 $\$1,000 + (\$1,000 \times \text{Basket Return} \times \text{Upside Leverage Factor})$ , subject to the Maximum Return  
 If the Final Basket Value is equal to the Initial Basket Value or is less than the Initial Basket Value by up to the Buffer Amount, you will receive the principal amount of your notes at maturity.  
 If the Final Basket Value is less than the Initial Basket Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  
 $\$1,000 + \$1,000 \times (\text{Basket Return} + \text{Buffer Amount}) \times \text{Downside Leverage Factor}$   
 If the Final Basket Value is less than the Initial Basket Value by more than the Buffer Amount, you will lose some or all of your principal amount at maturity.

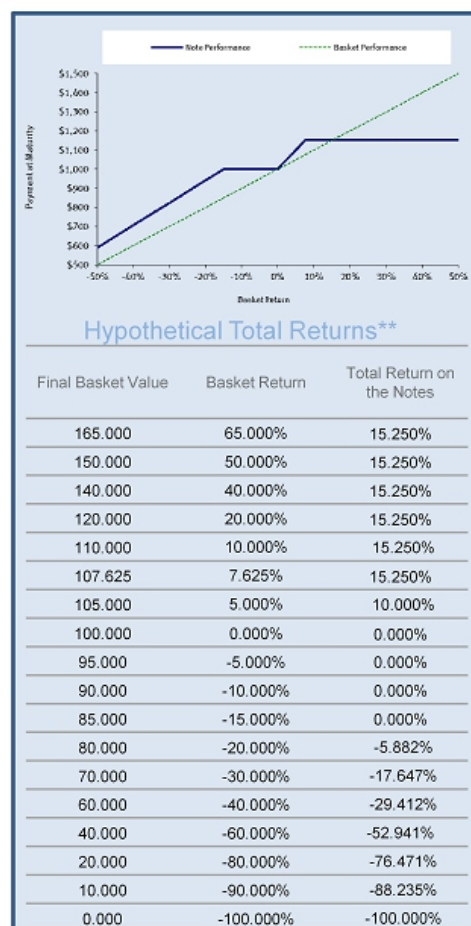
