

2yr INDU/SPX Capped Dual Directional Buffered Return Enhanced Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

**Minimum Denomination:** \$1,000  
**Underlyings:** Dow Jones Industrial Average® and S&P 500® Index  
**Pricing Date:** December 19, 2025  
**Observation Date:** December 20, 2027  
**Maturity Date:** December 23, 2027  
**Upside Leverage Factor:** 1.25  
**Maximum Upside Return:** At least 18.50%\*  
**Buffer Amount:** 20.00%  
**Payment At Maturity:** If the Final Value of each Underlying is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return} \times \text{Upside Leverage Factor}),$$

subject to the Maximum Upside Return

If (i) the Final Value of one Underlying is greater than its Initial Value and the Final Value of the other Underlying is equal to its Initial Value or is less than its Initial Value by up to the Buffer Amount or (ii) the Final Value of each Underlying is equal to its Initial Value or is less than its Initial Value by up to the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Absolute Underlying Return of the Lesser Performing Underlying})$$

*This payout formula results in an effective cap of 20.00% on your return at maturity if the Lesser Performing Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,200.00 per \$1,000 principal amount note.*

If the Final Value of either Underlying is less than its Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + [\$1,000 \times (\text{Lesser Performing Underlying Return} + \text{Buffer Amount})]$$

*If the Final Value of either Underlying is less than its Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity.*

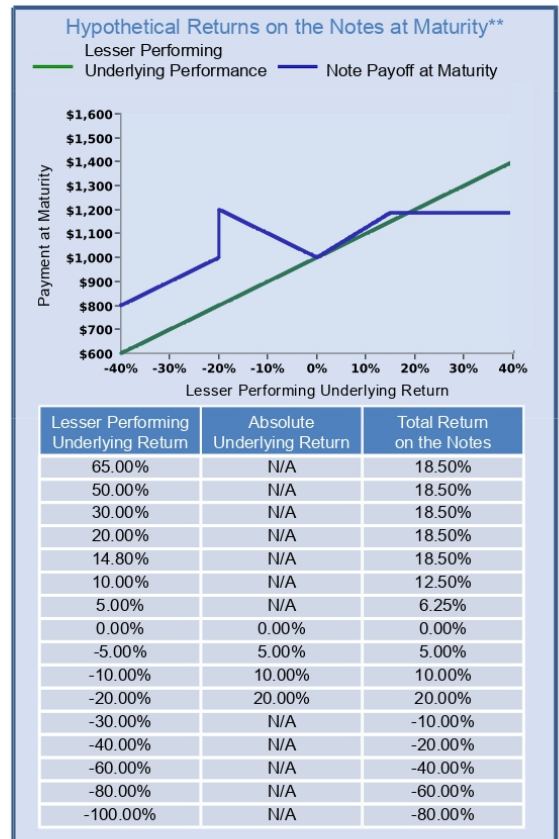
