Payment at Maturity

If the Final Value of each Underlying is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be

If (i) the Final Value of one or more Underlyings is greater than its Initial Value and the Final Value of the other Underlying or Underlyings is equal to its Initial Value or is less than its Initial Value by up to the Buffer Amount or (ii) the Final Value of each Underlying is equal to its Initial Value or is less than its Initial Value by up to the Buffer Amount, you will receive the principal amount of your notes at maturity.

If the Final Value of any Underlying is less than its Initial Value by more than the Buffer Amount, you will lose 1% of the principal amount


of your notes for every 1% that the least performing Underlying has declined beyond the Buffer Amount
