

12-Month KKR Contingent Income Auto-Callable Securities

This document provides a summary of the terms of the securities. SUMMARY TERMS

Issuer:	JPMorgan Chase Financial Company LLC ("JPMorgan Financial")
Guarantor:	JPMorgan Chase & Co.
Underlying stock:	Common stock of KKR & Co. Inc. (Bloomberg ticker: KKR UN Equity)
Early redemption:	If, on any determination date (other than the final determination date), the closing price of the underlying stock is greater than or equal to the initial stock price, the securities will be automatically redeemed for an early redemption payment on the first contingent payment date immediately following the related determination date. No further payments will be made on the securities once they have been redeemed. The securities will not be redeemed early on any contingent payment date if the closing price of the underlying stock is below the initial stock price on the related determination date.
Early redemption payment:	The early redemption payment will be an amount equal to (i) the stated principal amount <i>plus</i> (ii) the contingent quarterly payment with respect to the related determination date <i>plus</i> (iii) any previously unpaid contingent quarterly payments with respect to any prior determination dates.
Contingent quarterly payment:	- If, on any determination date, the closing price of the underlying stock is greater than or equal to the downside threshold level, we will pay a contingent quarterly payment of at least \$28.625 (at least 2.8625% of the stated principal amount) per security on the related contingent payment date <i>plus</i> any previously unpaid contingent quarterly payments with respect to any prior determination dates. The actual contingent quarterly payment will be provided in the pricing supplement. However, even if any unpaid quarterly payment is payable on a later contingent payment date, no additional interest will accrue or be payable in respect of that unpaid contingent quarterly payment. - If, on any determination date, the closing price of the underlying stock is less than the downside threshold level, no contingent quarterly payment will be made with respect to that determination date. It is possible that the closing price of the underlying stock will be below the downside threshold level on most or all of the determination dates so that you will receive few or no contingent quarterly payments.

Contingent payment dates:	January 7, 2027, April 7, 2027, July 8, 2027 and the maturity date
Payment at maturity:	- If the final stock price is greater than or equal to the downside threshold level: (i) the stated principal amount <i>plus</i> (ii) the contingent quarterly payment with respect to the final determination date <i>plus</i> (iii) any previously unpaid contingent quarterly payments with respect to any prior determination dates - If the final stock price is less than the downside threshold level: (i) the stated principal amount <i>times</i> (ii) the stock performance factor. This cash payment will be less than 60% of the stated principal amount of the securities and could be zero.
Downside threshold level:	60% of the initial stock price
Initial stock price:	The closing price of the underlying stock on the pricing date
Final stock price:	The closing price of the underlying stock on the final determination date

Stock adjustment factor:	The stock adjustment factor is referenced in determining the closing price of the underlying stock and is set initially at 1.0 on the pricing date. The stock adjustment factor is subject to adjustment in the event of certain corporate events affecting the underlying stock.
