

## 3yr Capped Digital SPX Notes

## Summary of Terms

**Observation Date:** December 1, 2025  
**Maturity Date:** December 4, 2025  
**Contingent Digital Return:** At least 20.00%\*  
**Payment at Maturity:** If the Final Value is greater than or equal to the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Contingent Digital Return})$$
If the Final Value is less than the Initial Value, you will receive the principal amount of your notes at maturity.

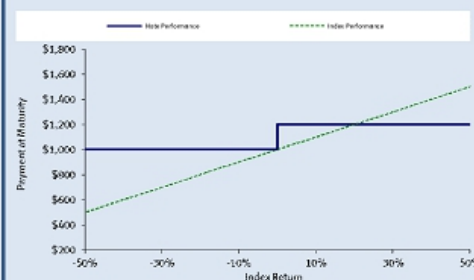

## Selected Risks
