









Because the Final Share Price of the Reference Stock is \$24.00, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$500.

Example 4: The Final Share Price of \$38.40 is less than the Initial Share Price of \$48.00 but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. 

Because the Final Share Price of the Reference Stock is \$17.50, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$500.

Example 4: The Final Share Price of \$28.00 is less than the Initial Share Price of \$35.00 but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period.
