If the Ending Index Level is greater than the Initial Index Level, you will receive a cash payment that provides you with a return per \$1,000 principal amount note equal to the Index Return multiplied by two, subject to a Maximum Total Return on the notes of 14.40%*. For example, if the Index Return is more than 7.20%, you will receive the Maximum Total Return on the notes of 14.40%*, which entitles you to a maximum payment at maturity of \$1,144 for every \$1,000 principal amount note that you hold. 

Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 1500 to an Ending Index Level of 1575. Because the Ending Index Level of 1575 is greater than the Initial Index Level of 1500 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 14.40%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note calculated as follows:

$$1,000 + [1,000 \times (5\% \times 2)] = 1,100$$

Example 2: The level of the Index decreases from the Initial Index Level of 1500 to an Ending Index Level of 1350. Because the Ending Index Level of 1350 is less than the Initial Index Level of 1500 by not more than the Buffer Amount of 10%, the investor will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index increases from the Initial Index Level of 1500 to an Ending Index Level of 1800. Because the Ending Index Level of 1800 is greater than the Initial Index Level of 1500 and the Index Return of 20% multiplied by 2 exceeds the hypothetical Maximum Total Return of 14.40%, the investor receives a payment at maturity of \$1,144 per \$1,000 principal amount note, the maximum payment on the notes.

Example 4: The level of the Index decreases from the Initial Index Level of 1500 to an Ending Index Level of 1200. Because the Ending Index Level of 1200 is less than the Initial Index Level of 1500 by more than the Buffer Amount of 10%, the Index Return is negative and the investor will receive a payment at maturity of \$888.89 per \$1,000 principal amount note calculated as follows:



- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive or negative. Your investment will be exposed on a leveraged basis to any decline in the Ending Index Level beyond the 10% buffer as compared to the Initial Index Level.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the Ending Index Level is greater than the Initial Index Level, for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional amount that will not exceed a predetermined percentage of the principal amount, regardless of the appreciation in the Index, which may be significant.
