Estimated Value:	The estimated value of the notes, when the terms of the notes are set, will not be less than \$950.00 per \$1,000 principal amount note. Payment at Maturity

If the Final Value is greater than or equal to the Initial Value or is less than the Initial Value by up to the Buffer Amount, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 *plus* (b) the Interest Payment applicable to the Maturity Date.

If the Final Value is less than the Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note, in addition to the Interest Payment applicable to the Maturity Date, will be calculated as follows:

$$\$1,000 + [\$1,000 \times (\text{Stock Return} + \text{Buffer Amount})]$$

If Final Value is less than the Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity and could lose all of your principal amount at maturity.

Interest Payments

You will receive on each Interest Payment Date for each \$1,000 principal amount note an Interest Payment equal to \$16.25 (equivalent to an interest rate of 6.50% per annum, payable at a rate of 1.625% quarterly).

The hypothetical payments on the notes shown above apply only if you hold the notes for their entire term. These hypotheticals do not reflect fees or expenses that would be associated with any sale in the secondary market. If these fees and expenses were included, the hypothetical payments shown above would likely be lower.
